

## **TERMS AND CONDITIONS**

**WHAT IS INCLUDED:** Land arrangements: Accommodations based on double occupancy, full buffet breakfast with dinners and lunches as described in itinerary, plus a farewell gourmet dinner, baggage handling, English-speaking tour escort, pre-trip information, service charges and taxes.

**WHAT IS NOT INCLUDED:** Air travel, passport fees, personal items such as wines, liquor, a-la-carte orders, lunches and dinners(except as noted in itinerary), room service and valet/laundry services, gratuity to the coach driver and other items not specifically mentioned as included. Air travel can be arranged separately by TT&A from Washington Dulles International Airport to/from Munich. Call TT&A (703) 360-1999 for details.

**PAYMENT SCHEDULE:** Two hundred fifty dollars (\$250) non-refundable deposit by check with application. Final payment due to TT&A by **September 2, 2008**.

**REFUND POLICY:** Land tour cancellation fee: \$250.00 before 2 September 2008; no refund if cancelled after that date (and no substitute from the waiting list can be booked in time).

**INSURANCE:** Trip cancellation, baggage, health and accident insurance are available from TT&A and are highly recommended. Pre-existing conditions are covered if such insurance is ordered within seven (7) days of submitting tour deposit.

**BAGGAGE:** Portage of one bag per person is provided free of charge at hotels.

**ITINERARY OR PROGRAM MODIFICATIONS:** While every effort will be made to carry out the program as described herein, it is subject to modification by the Tour Escort.
